Canadian-owned GreenPower Motor Company Inc., a leading manufacturer and distributor of zero-emission, electric-powered, medium- and heavy-duty vehicles, will be manufacturing zero-emission, all-electric school buses in its newly-acquired 9.5-acre manufacturing facility in South Charleston. The plant will create up to 900 jobs in West Virginia. In addition, three all-electric GreenPower Type D BEAST school buses will be deployed in Mineral, Lewis and Harrison school districts, while Upshur County will deploy the award-winning, all-electric Type A Nano BEAST. "GreenPower's BEAST and Nano BEAST continue to prove their capabilities in colder weather conditions and mountainous terrain," said GreenPower CEO and Chairman Fraser Atkinson. "We're committed to continue bringing healthier transportation alternatives to the children and communities of West Virginia to help reshape how students travel to and from school."



Pratt & Whitney: overhauling engines in West Virginia for over 50 years

In October 2021, Pratt & Whitney Canada, a business unit of Pratt & Whitney, celebrated the 50th anniversary of its Maintenance, Repair and Overhaul (MRO) facility – Pratt & Whitney Engine Services, Inc., located in Bridgeport. The facility employs around 400 people and overhauls between 500 and 600 engines a year. In 2019, Pratt & Whitney's U.S.-Canadian team, in collaboration with the state of West Virginia, announced a \$30 million investment to add a new MRO line to the facility. The new line became operational in 2021.



Canada invests in West Virginia


Trade with Canada supports 32,400 employees in West Virginia in addition to the 1,300 employees at Canadian-owned businesses across the state. In addition, West Virginia exports \$2.2 billion in goods and services to Canada.

Canadian-owned companies, including AltaGas, Brookfield Renewable U.S., Enbridge, Resolute Forest Products, Resolver, Stella-Jones, Total Energy Services, Trans Canada Energy, and West Virginia Air Center, are major contributors to West Virginia's economy. They employ residents in every sector and contribute to the local economy with salary dollars, paying local taxes, and the purchase of goods and services in their supply chain.
